# ARROW OPEN INCENTIVE FUND Rules & Program Information

## The Program Payout

• Payout will be from all enrolled stallions and all nominated horses each year

• Total payout will be divided evenly between the number of Host barrel races for the year - with 50% paid to owner and 50% paid to stallion owner

• Advertising and program costs are taken out of each enrollment and nomination received as follows:

- \$10 of every Stallion Enrollment
- \$25 of every Junior Stallion Enrollment
- \$5 of every Open Horse Entry Fee Received

### Enrolled Stallions (\$200 Stallion Enrollment - \$150 Junior Sire Enrollment)

• An enrollment form must be submitted with the enrollment fee by April 1st of the current year.

• All current stallion ads must be emailed to arrowproductionswi@gmail.com to be posted and printed off for advertising within the program

• Junior Stallions can enroll at a discounted fee of \$150 for the year - full program benefits will be included (advertising at events, social media, printing and banners, etc.)

- A Junior sire consists of a stallion that has no performing offspring currently competing or of age
- $\circ$  In its 1st year of being promoted as a stallion
- All enrolled stallions are listed on the website as they are received

• Enrolled stallions are eligible to compete and earn incentive money just as its offspring are through the program - they will receive both the owner & stallion \$\$ won

• In the case of a deceased stallion - a person has the ability to enroll a deceased stallion, as long as the original stallion owner gives consent for the incentive program to use the stallion's photo and ad. The stallion owner payout will be paid to the person who pays the enrollment fee. Stallion owners are given first rights to pay the enrollment fee to earn incentive money

• If a stallion owner does not wish to enroll their stallion, a person is allowed to enroll a stallion if given consent from the stallion owner to use the stallion's ad and/or photo for the incentive program. The stallion owner payout will be paid to the person who pays the enrollment fee. Stallion owners are given first rights to pay this fee to earn incentives.

#### Offspring / Nominated Horses (No Nominations - Just ENTER)

• A horse can enter at an incentive event and pay the Entry Fee, as long as the sire is or has been in the AOIF program at some point (\$40 Entry fee for Current | \$50 Entry fee for Past)

• If horse is sired by a stallion who has been in the AOIF program previously but does not re-enroll, the offspring can enter the incentive sidepots at the race for the Past Entry Fee rate (\$50)

• A copy of registered papers is required with your entry - NO EXCEPTIONS

#### **Event Results & Payback**

• Results will be posted on the Arrow Productions website within 5 days of the event. Checks will be mailed out that following week

• A W9 must be completed for Arrow Productions prior to any winnings being mailed out

• If an error occurs in the results after checks have been mailed, winnings are to be returned if requested and the new winnings will be sent out immediately.
