

ARROW OPEN INCENTIVE FUND RULES



The Program Payout

- Payout will be from all enrolled stallions and all nominated horses each year
- Total Payout will be divided evenly between the number of Host Open Barrel Races for the year – with 50% paid to Owner, & 50% paid to Stallion Owner.

The number of Host Events will depend on the monies collected of the current year:

Total payout less than \$10,000 – 2 Open Events Selected
Total payout less than \$15,000 – 3 Open Events Selected
Total payout more than \$15,001 – 4 Open Events Selected

The number of placings each Division is based on the number of Nominated Open Horses each Year:

0-50 Horses Nominated – Pay 2 Each Division
51-100 Horses Nominated – Pay 3 Each Division
101-200 Horses Nominated – Pay 4 Each Division
201-300 Horses Nominated – Pay 5 Each Division
301+ Horses Nominated – Pay 6 Each Division

Host Barrel Races

- Open barrel races considered must have verifiable proof of entries exceeding 200 entries each year
- Selection will be based on majority of location of nominated horses as well as Stallion Votes
- Stallions enrolled early in the program will be given the opportunity to vote for 2 events they feel would benefit their stallion's foals the most.
- Nominated horses must comply with the Show Producer's rules or risk forfeit of winnings in the program

Enrolled Stallions

- An enrollment form must be submitted with \$200 enrollment fee, OR stallions are allowed to donate a Breeding Fee to the Stallion Auction (Jan 1st – Jan 31st) – a minimum bid of \$250 is needed in order for the stallion to be enrolled into the program. If minimum bid is not met, the \$200 enrollment fee is due in order to be enrolled into the Program
- All current Stallion Ads must be emailed to ArrowProductionsWI@gmail.com to be posted and shared on the website and Incentive Program Book.
- All enrolled stallions are listed on the website as they are received.
- ***NEW*** Enrolled Stallions are eligible to earn incentive money just as its offspring are – they will receive both the owner & stallion \$\$ won – they must pay the nomination due in addition to the stallion enrollment fee.
- No stallions are accepted after Enrollment deadline
- In the case of a Deceased Stallion – A Person has the ability to enroll a deceased stallion, as long as the original stallion owner gives consent for the Incentive Program to use the Stallion Ad. The Stallion Owner payout will be paid to the person who pays the Enrollment fee. Stallion Owners are given first rights to pay the Enrollment fee to earn incentives.
- If a Stallion Owner does not wish to enroll their stallion themselves, a person is allowed to enroll a stallion if given consent from the Stallion owner to use the Stallion Ad for the Incentive Program. The Stallion Owner payout will be paid to the person who pays the Enrollment fee. Stallion Owners are given first rights to pay the Enrollment fee to earn incentives.

Nominated Horses

- A horse can be nominated at any point in its barrel racing career, as long as the stallion it is sired by is a Currently Enrolled stallion for that nomination year.
- Previously nominated horses can re-nominate if a stallion does not re-enroll for the alternative fee. Any stallion \$\$ won for un-enrolled stallions will drop down to the next eligible stallion.
- A nomination form must be sent with all paperwork, copy of registered papers, and nomination fee due each year.
- All nominated Open horses are listed on the website as they are received.
- Late nominations are accepted after the deadline with a \$10 Late fee
- \$5 Processing Fee per horse will be kept to cover expenses of the Incentive Fund – program printing, advertising, mailings, etc.

Event Results & Payback

- Results from the host event must be sent to Arrow Productions within 1 week of the event at ArrowProductionsWI@gmail.com
- Incentive Results will be verified and posted on the website once received & winnings will be mailed out one week after to the listed Rider on submitted results, horse owners, & Stallion Owners.
- A W9 must be completed for Arrow Productions prior to any winnings being mailed out.
- If an error occurs in the results after checks have been mailed, winnings are to be returned if requested and the new winnings will be sent out immediately.
